## **BIO:**

After completing law school and medical school I completed my internal medicine training in Brooklyn, New York. I was voted resident of the year and upon completion of my residency was elected to be chief resident. I did a chief resident year and matched in a Pulmonary/Critical Care Fellowship program at George Washington University. Out of over 60 fellows I was voted Fellow of the Year by my peers and attending physicians. I began my professional career at a hospital in Maryland which is where I still work.
